SPOKANE AQUIFER JOINT BOARD MEETING MINUTES

December 18, 2003

1) CALL TO ORDER

The Board of Directors of the Spokane Aquifer Joint Board (SAJB) met in Regular Session at Vera Water and Power, 601 N. Evergreen, Spokane, Washington on December 18, 2003. President Wick welcomed those in attendance and called the meeting to order at 1:33 PM.

Board of Directors Roll Call and Introductions

President Ty Wick, Vice-President Bob Ashcraft, Treasurer Steve Skipworth and Secretary Kathleen Small were in attendance. A total of 11 attended the meeting, 11 representing SAJB members, Program Leader Julia McHugh and 1 guest.

Consideration of November 20, 2003 Regular Meeting Minutes

The Regular Meeting Minutes of November 20, 2003 were approved as presented.

2) FINANCE COMMITTEE REPORT

SAJB Administration Funds

Treasurer Steve Skipworth reported as follows: The SAJB Checking Account balance is \$1,087.30 and the Spokane County Investment Pool (Wellhead Protection) balance is \$4,508.88. Treasurer Skipworth noted that three SAJB entities have not paid their dues to date.

SAJB Wellhead Implementation Plan (WIP) Funds

Kim Orlob reported as follows: The WIP checking balance is \$83,632.76, the Spokane County Investment Pool (Implementation) is \$63,425.34 and Implementation Savings is \$72.84

Presented/Approved Administration and WIP Bills

President Wick presented the attached December 2003 Bill Payment Summary- Total: \$ 4,643.82. Those present reviewed the summary. Bob Ashcraft made the motion, and Jim Lahde seconded, that the bills be paid in accordance with the presented summary. Administration Bills: None. Wellhead Implementation Bills of \$ 4,643.82, which includes the Program Leader Fee, plus mileage and reimbursable in the amount of \$ 4,260.49 for the period November 19, 2003 through December 16, 2003. President Wick called for the vote, the motion passed unanimously.

3) OLD BUSINESS

Aguifer quantity study by Washington-Idaho-US Geological Survey

President Wick reported the Study has been partially funded (\$500,000 of an estimated cost of 3.5 Million) and the three entities (Washington, Idaho and US Geological) have put together a memorandum of understanding (MOU) and the MOU has been signed.

4) NEW BUSINESS

New Budgets for 2004

President Wick reviewed the proposed 2004 SAJB Administration Budget with those present; the proposed dues per SAJB entity are \$150 each per year. Jim Lahde made the motion, and Terry Squibb seconded, the proposed 2004 Budget be accepted as presented. President Wick called for the vote, the motion passed unanimously.

President Wick noted that 3 of the 4 Wellhead Implementation Committee Budgets are ready and he suggested waiting for the 4th and then presenting all of the proposed 2004 Committee Budgets at the January meeting. Those present agreed to wait until the January meeting to review all of the budgets at once.

Program Leader Contract Extension

President Wick stated the Board would meet in executive session for approximately 15 minutes to discuss personnel matters. Program Leader McHugh excused herself from the meeting.

The Board returned to Regular Session. Jim Lahde made the motion that the SAJB Program Leaders compensation be increased by 3.5% (as recommended by the Executive Committee) and the SAJB contract with the Program Leader be extended one year. Terry Squibb seconded the motion. President Wick called for the vote, the motion passed unanimously. Program Leader McHugh rejoined the meeting.

The Executive Committee asked the Program Leader to stay after the meeting to further discuss the member's decision regarding her contract.
