1) CALL TO ORDER

The Board of Directors of the Spokane Aquifer Joint Board (SAJB) met in Regular Session at Modern Electric Water Company, 904 N. Pines, Spokane, Washington on December 16, 2004. President Wick welcomed those in attendance and called the meeting to order at 1:30 PM.

Board of Directors Roll Call and Introductions

President Ty Wick, Vice-President Bob Ashcraft, Treasurer Steve Skipworth and Secretary Kathleen Small were in attendance. A total of 20 attended the meeting, 14 representing 15 SAJB members, Program Leader Julia McHugh and 5 Guests.

Consideration of Regular Meeting Minutes

President Wick called for any additions, corrections or comments on the Minutes of November 18, 2004. None were received, President Wick declared the Minutes of November 18, 2004 approved as presented.

2) FINANCE COMMITTEE REPORT

SAJB Administration Funds

Treasurer Steve Skipworth reported as follows: The SAJB Checking Account balance is \$4,309.77 and the Spokane County Investment Pool (Wellhead Protection) balance is \$1,105.99. Treasurer Skipworth stated 2004 yearly dues statements were distributed, a majority of these payments have been received and are reflected in the checking account balance.

SAJB Wellhead Implementation Plan (WIP) Funds

Mary McIntyre, City of Spokane Accountant, reported as follows: The WIP checking balance is \$ 26,915.73, the Spokane County Investment Pool (Implementation) is \$ 44,908.43 and Implementation Savings is \$73.11.

Presented/Approved Administration and WIP Bills

President Wick presented the attached December 2004 Bill Payment Summary - Total \$ 5,786.27. Those present reviewed the summary. President Wick stated that KSPS has billed SAJB for a quarterly payment, however, he recommends that payment be withheld as SAJB has already paid \$30,000 to date and he feels that a better accounting of activities is needed before any additional payment is made. Gary Lowe made the motion, and Terry Squibb seconded, that the bills be paid in accordance with the presented summary and that payment to KSPS be withheld at this time. The summary detailed Wellhead Implementation Bills of \$ 5,786.27 including the Program Leader Fee, plus mileage and reimbursement, total \$ 5,561.27 for the period 11/16/04 through 12/15/04. President Wick called for the vote, the motion passed unanimously.

3) OLD BUSINESS

Aguifer quantity study by Washington-Idaho-US Geological Survey (Study)

President Wick discussed latest activities, also see Program Leader Report. He encouraged all to attend the meetings.

2005 SAJB Administrative Budget

Those present reviewed and discussed the Budget as presented by Treasurer Skipworth. Terry Squibb made the motion, and Bob Ashcraft seconded that the 2005 SAJB Administrative Budget (Total: \$3,000) be approved as presented. President Wick called for the vote, the motion passed unanimously.

4) NEW BUSINESS

Kaiser Mead

President Wick reported Kaiser Mead has withdrawn from SAJB membership.

Program Leader Contract

President Wick reported the Program Leader Contract needs to be updated, reviewed by the SAJB Attorney and a new contract prepared. The SAJB Executive Board will begin the process as soon as possible.

The Program Leader noted the 2004 Year-end report has been provided to all SAJB members.

Program Leader McHugh noted that the Subcommittees have preliminarily reviewed the 2005 Budgets; she is awaiting additional information on costs prior to completing the Household and PCSI committee budgets.

- 4) Dept of Ecology Underground Injection Control rule making per Bill Rickard: Ecology UIC Rule Revision Activity.url http://www.ecy.wa.gov/programs/wq/grndwtr/uic/rule_rev.html, contains adobe acrobat file from power point, same as presented 11/16/04; Eastern WA stormwater manual standards allows for local rules due to local stormwater conditions; local jurisdictions in Spokane County meeting to flesh out regional stormwater manual; City of Spokane Valley proposing making stormwater swales 40% smaller, based on swale to handle but not treat. Proposed reduced design does comply with stormwater manual parameters. City of Spokane and Spokane County not opposed to smaller swale sizes, but concerned about water quality issues; UIC formal rule-making starting Jan '05, along with public comment period; Final rule expected in June 2005. - 5) BNSF Refueling Depot Leak 12/11/04, as reported on KPBX: leaking pipe carrying various materials detected upon routine maintenance; trench 32' deep dug and 200 cu yd material removed; no indication it has reached aquifer level
