- a) Aquifer Atlas reprinting next meeting scheduled for March 24th; Dennis Owsley, IDEQ, has field studies that redefine the aquifer boundary between Round Mountain and the Chilco Channel after scientific review/acceptance, and if within the printing time frame, this new boundary will be included in the revised Atlas. Kerry Brooks, WSU Landscape Architecture GIS Lab, has 2 good satellite images of July 1986 and 2003, and has begun processing to produce the 'Change Map', which will depict past and present development over the Aquifer.

6. ADJOURN

1) CALL TO ORDER

The Board of Directors of the Spokane Aquifer Joint Board (SAJB) met in Regular Session at Vera Water and Power, 601 N. Evergreen, Spokane, Washington on January 22, 2004. President Wick welcomed those in attendance and called the meeting to order at 1:30 PM.

Board of Directors Roll Call and Introductions

President Ty Wick, Vice-President Bob Ashcraft, Treasurer Steve Skipworth and Secretary Kathleen Small were in attendance. A total of 17 attended the meeting, 15 SAJB member representatives, Program Leader Julia McHugh and Rick Barlow, Panhandle Health/Aquifer Protection.

Consideration of December 18, 2003 Regular Meeting Minutes

President Wick called for additions, corrections or comments on the Minutes of December 18, 2003. None were received; President Wick stated that the Minutes of December 18, 2003 were approved as presented.

2) FINANCE COMMITTEE REPORT

SAJB Administration Funds

Treasurer Steve Skipworth reported as follows: The SAJB Checking Account balance is \$4,441.30 and the Spokane County Investment Pool (Wellhead Protection) balance is \$1,089.09. Treasurer Skipworth noted he has one bill for post office box rental in the amount of \$68.00. And that membership for Kaiser Trentwood and Honeywell has lapsed due to non-payment of dues.

SAJB Wellhead Implementation Plan (WIP) Funds

Kim Orlob reported as follows: The WIP checking balance is \$34,705.42, the Spokane County Investment Pool (Implementation) is \$123,631.67 and Implementation Savings is \$72.86. Ms. Orlob reported all SAJB entities have paid the 2003 Assessment.

Presented/Approved Administration and WIP Bills

President Wick presented the attached January 2004 Bill Payment Summary- Total \$ 5,675.96. Those present reviewed the summary. Dave Johnson made the motion, and Terry Squibb seconded, that the bills be paid in accordance with the presented summary. The summary detailed Administration Bills of \$68.00 and Wellhead Implementation Bills of \$5,607.96, which includes the Program Leader Fee, plus mileage and reimbursement in the amount of \$ 5,410.63 for the period December 17, 2003 through January 20, 2004. President Wick called for the vote, the motion passed unanimously.

3) OLD BUSINESS

Aguifer quantity study by Washington-Idaho-US Geological Survey

President Wick and Program Leader McHugh reported there is no new news about the Study.

Program Leader Contract Extension

President Wick reported the Program Leader Contract has been extended for one year.

Ecology Grant Time Extension

President Wick reported the grant has been extended one year. Program Leader McHugh reported she has talked with Ecology about the Education Work Plan for 2004 and she was told informally the plan looked good, would be approved as presented.

4) NEW BUSINESS

WIP Budget for 2004

President Wick presented the Budget Worksheet – Year-End 2003 and Projected 2004. Those present reviewed and discussed the budget and approved the proposed 12 cents per service per month assessment for six months which will be billed to member entities in June of 2004. Walt McKee made the motion and Bob Ashcraft seconded the 2004 Budgets be approved as presented. President Wick called for the vote, the motion carried unanimously.

KDK-1 Task Order # 2004-01 for new TV Spot

President Wick presented the Task Order for the new TV Spot for \$4,000. Those present approved the Task Order as presented.

Spokane County Aquifer Protection Tax

President Wick reported that the tax Spokane County levies for Aquifer Protection sunsets in 2005. He has discussed the possibility of extending this tax with Bruce Rawls, Spokane County Utilities. Mr. Rawls is currently drafting letters, on behalf of Spokane County, to the Cities that must also agree to place this issue before the voters to extend this tax. Once he has contacted the Cities he is anticipating a meeting with interested parties to develop a plan to inform the electorate regarding the need for extending this tax and possibly expanding the ways in which the tax money may be used to protect the Aquifer.

Minutes of the SAJB Meeting; continued:

Discussion followed. Those present directed President Wick to participate in this effort and express SAJB's support in placing the renewal of the Aquifer Protection Tax on the ballot.

Gary Lowe made the motion, and Terry Squibb seconded, that President Wick write a letter to the Spokane County Planning Commission expressing SAJB's concern in general about changes in the Shorelines Rules - septic tanks.
