#### SPOKANE AQUIFER JOINT BOARD MEETING MINUTES

February 26, 2004

#### 1) CALL TO ORDER

The Board of Directors of the Spokane Aquifer Joint Board (SAJB) met in Regular Session at Vera Water and Power, 601 N. Evergreen, Spokane, Washington on February 26, 2004. President Wick welcomed those in attendance and called the meeting to order at 1:35 PM.

#### **Board of Directors Roll Call and Introductions**

President Ty Wick, Vice-President Bob Ashcraft, Treasurer Steve Skipworth and Secretary Kathleen Small were in attendance. A total of 15 attended the meeting, 14 SAJB member representatives (2 from Whitworth) and Program Leader Julia McHugh.

#### Consideration of January 22, 2004 Regular Meeting Minutes

President Wick called for additions, corrections or comments on the Minutes of January 22, 2004. None were received; President Wick stated that the Minutes of January 22, 2004 were approved as presented.

#### 2) FINANCE COMMITTEE REPORT

#### **SAJB Administration Funds**

Treasurer Steve Skipworth reported as follows: The SAJB Checking Account balance is \$4,441.30 and the Spokane County Investment Pool (Wellhead Protection) balance is \$1,090.87.

#### SAJB Wellhead Implementation Plan (WIP) Funds

Kim Orlob reported as follows: The WIP checking balance is \$28,947.46, the Spokane County Investment Pool (Implementation) is \$123,631.67 and Implementation Savings is \$72.88.

#### Presented/Approved Administration and WIP Bills

President Wick presented the attached February 2004 Bill Payment Summary- Total \$ 21,479.70. Those present reviewed the summary. Bob Ashcraft made the motion, and Jim Lahde seconded, that the bills be paid in accordance with the presented summary. The summary detailed Administration Bills of - 0 - and Wellhead Implementation Bills of \$ 21,479.70, which includes the Program Leader Fee, plus mileage and reimbursement in the amount of \$ 7,344.02 for the period January 21, 2004 through February 24, 2004. President Wick called for the vote, the motion passed unanimously.

#### 3) OLD BUSINESS

#### Aquifer quantity study by Washington-Idaho-US Geological Survey (Study)

President Wick and Program Leader McHugh reported the Study is in the process of identifying tasks and data gaps. Also they are working on a request for the additional 3 million dollars needed to complete the study.

#### Letter to Planning Commission regarding Shorelines Septic Tank Location

President Wick reported that as per the minutes of January 22, 2004 he wrote the letter to the Spokane County Planning Commission expressing SAJB concerns with changing the Shorelines Septic Tank Location ordinance. He reported that the Planning Commission voted unanimously to reject the requested change. This recommendation was forwarded to the Spokane County Commissioners for final action.

#### 4) NEW BUSINESS

#### KDK-1 Task Order # 2004-02 Media Purchase

President Wick presented the Task Order for Media Purchase of \$10,420, with spots airing from February 1st through April 15th. President Wick and Secretary Small proposed that the media purchase be split 50/50 between the Household Hazardous Waste Committee and the Education Committee. Discussion followed. Those present approved the proposed split and the Task Order as presented.

#### Resolution 2004-01 – Virtual Field Trip 2 (for youngsters)

President Wick reported the first virtual field trip has been a huge success and this proposal is to have (Persistent Vision) develop another one to target 2<sup>nd</sup> through 5<sup>th</sup> grades. Discussion followed.

Terry Squibb made the motion, and Jim Lahde seconded that Resolution 2004-01 be adopted as written. President Wick called for the vote: Those in Favor 11, Those Against – None, Abstain – None, Absent 7. President Wick declared the motion carried. *Note: East Spokane, Carl Jackson, joined the meeting after Resolution 2004-01 was voted upon consequently the East Spokane vote was counted as absent.*
