# 1) CALL TO ORDER

The Board of Directors of the Spokane Aquifer Joint Board (SAJB) met in Regular Session at Vera Water and Power, 601 N. Evergreen, Spokane, Washington on March 25, 2004. President Wick welcomed those in attendance and called the meeting to order at 1:30 PM.

### **Board of Directors Roll Call and Introductions**

President Ty Wick, Treasurer Steve Skipworth and Secretary Kathleen Small were in attendance. Vice President Bob Ashcraft was absent. A total of 17 attended the meeting, 12 SAJB member representatives, Program Leader Julia McHugh and 4 Guests.

#### **Consideration of Regular Meeting Minutes**

President Wick called for additions, corrections or comments on the Minutes of February 26, 2004. None were received; President Wick stated that the Minutes of February 26, 2004 were approved as presented.

# 2) FINANCE COMMITTEE REPORT

### SAJB Administration Funds

Treasurer Steve Skipworth reported as follows: The SAJB Checking Account balance is \$4,592.02 and the Spokane County Investment Pool (Wellhead Protection) balance is \$1,092.48.

### SAJB Wellhead Implementation Plan (WIP) Funds

President Wick reported for Kim Orlob as follows: The WIP checking balance is \$ 7,467.76, the Spokane County Investment Pool (Implementation) is \$123,833.46 and Implementation Savings is \$72.90.

#### Presented/Approved Administration and WIP Bills

President Wick presented the attached March 2004 Bill Payment Summary- Total \$ 10,766.42. President Wick explained that payment for the Earth Day Booth of \$100.00 is for a registration fee of \$35.00 and a \$65.00 donation; he asked those present if they wanted to continue the \$65.00 donation? Those present reviewed the summary. Jim Lahde made the motion, and Dave Johnson seconded, that the bills be paid in accordance with the presented summary, which includes a donation of \$65.00 to Earth Day. The summary detailed Administration Bills of -0 - and Wellhead Implementation Bills of \$10,766.42, including the Program Leader Fee, plus mileage and reimbursement, total \$4,469.36 for the period February 25, 2004 through March 23, 2004. President Wick called for the vote, the motion passed unanimously.

#### Aquifer quantity study by Washington-Idaho-US Geological Survey (Study) – TAC Representative

President Wick reported the Study is formulating a Technical Advisory Committee (TAC) and is looking for a hydrologist by March 31, 2004. Discussion followed concerning a hydrologist that could represent SAJB to insure that the technical aspects of the study were appropriate and would correspond with the existing data.

Jim Lahde made the motion, and Danny Wren seconded, that up to \$1,000 of SAJB Administrative Funds be used to fund a hydrologist representative to the Study; Chuck Gruenenfelder with CH2M-Hill. With the understanding this will allow President Wick to contact Mr. Gruenenfelder and at a minimum fund his attendance at Study meetings between now and the next SAJB meeting. When additional information about the anticipated costs and Study time commitments is available SAJB members will discuss the subject again. President Wick called for the vote, the motion passed unanimously.

#### Draft Fluoridation Fact Sheet

Program Leader McHugh reported the Fluoridation Fact Sheet Committee met prior to this meeting and the 2<sup>nd</sup> Rough Draft is in progress, the final rough should be ready in about two weeks. Secretary Small noted she would like to include the fact sheet with the CCR to be mailed to customers this spring.
