<u>Household Contaminant Disposal</u> – October disposal campaign results:

Media coverage: 46 TV, 35 radio spots and 4 print ads were run, and banners placed at each Transfer Station; Retired Senior Volunteer Program picked up from 3 households with 2 pickups pending;

Recycle Hotline for October had 61 calls up from 42 in 2002.

Guest Speaker – Michele Vasquez, Department of Health, Division of Drinking Water, Topic: Interpretation of HB1338, water conservation requirements for Water Districts

- a) Aquifer Atlas reprinting next Atlas revision meeting December 3^{rd.} Landsat image purchase, georeferencing and change mapping cost of \$1200 being made possible by Education Subcommittee
- Spokane County Critical Areas Ordinance –changes approved by Planning and County Commissioners, a few edits to be completed by County Planning staff, expect it to be posted to County website by November 3rd
- c) Idaho/Washington Aquifer Study President signed \$500,000 appropriation; MOU signing ceremony being planned for December 11th; very few comments on draft MOU, therefore it's not expected to change much
- d) On 11/12, Coeur d'Alene Basin Commission approved the 2nd 1-yr work plan with 70% funds for work on the ground, primarily to clean up residential yards in upper basin; the 1st work plan was for a 3-year duration, the funds allocated to studies in the lake; this scope of work is ongoing. Planning group is addressing streambank issues and resulting scope of work

1. CALL TO ORDER

The Board of Directors of the Spokane Aquifer Joint Board (SAJB) met in Regular Session at Vera Water and Power, 601 S. Evergreen Road, Spokane, Washington on October 23, 2003. President Wick welcomed those in attendance and called the meeting to order at 1:34 PM.

Board of Directors Roll Call and Introductions

President Ty Wick, Treasurer Steve Skipworth and Secretary Kathleen Small were in attendance. Vice-President Bob Ashcraft was absent. A total of 16 attended the meeting, 12 SAJB member representatives, Program Leader Julia McHugh and three guests.

Consideration of June 26, 2003 Regular Meeting Minutes and September 18, 2003 Informational Session Minutes

The Regular Meeting Minutes of June 26, 2003 and the Information Session Minutes of September 18, 2003 were approved as presented.

2. FINANCE COMMITTEE REPORT

SAJB Administration Funds

Treasurer Steve Skipworth reported as follows: The SAJB Checking Account balance is 4,563.24 and the Spokane County Investment Pool (Wellhead Protection) balance is 1,083.91. Treasurer Skipworth noted that 20 entities have paid their 2003 Dues to date.

SAJB Wellhead Implementation Plan (WIP) Funds

Kim Orlob reported as follows: The WIP checking balance is \$ 37,657.33, the Spokane County Investment Pool (Implementation) is \$63,160.97 and Implementation Savings is \$ 72.80.

Presented/Approved Administration and WIP Bills

President Wick presented the attached October 2003 Bill Payment Summary- Total \$9,084.97. Those present reviewed the summary. Terry Squibb made the motion, and Walt McKee seconded, that the bills be paid in accordance with the presented summary. The summary detailed Administration Bills of \$ 0.00 and Wellhead Implementation Bills of \$ 9084.97, which includes the Program Leader Fee, plus mileage and reimbursable in the amount of \$ 5,620.64 for the period September 16 to October 21, 2003. President Wick called for the vote, the motion passed unanimously.

Walt McKee made the motion, and Lynn Plaggemeier seconded, that the bills paid as authorized by the SAJB Officers for the months July, August and September of 2003 be ratified. President Wick called for the vote, the motion passed unanimously.

3. OLD BUSINESS

Aguifer Quantity Study (AQS)

President Wick reported funding of \$500,000 is still in progress and the MOU between Washington, Idaho and USGS is in draft form and can be reviewed on USGS website – see Program Leader Report Item c) for address.

Election of Officers

Dave Johnson made the motion, and Walt McKee seconded, to nominate the current slate of officers for re-election. President Wick called for the vote, the motion passed unanimously. As Elected: President Ty Wick, Vice-President Bob Ashcraft, Treasurer Steve Skipworth, and Secretary Kathleen Small.

Annual Assessment for Wellhead Implementation Plan

President Wick reported that those present at the September meeting felt it was prudent to assess SAJB members for the second half of SAJB Wellhead Implementation Plan Monies; bills have been prepared. President Wick passed out the bills to those members present. SAJB members who were not present will be receiving their invoices through the mail. He noted that the 2003 assessment was set at 12 cents per connection for twelve months, however the membership has chosen to only assess for the second half; 12 cents per connection for six months.

4. NEW BUSINESS

Resolution 2003-08 – Household Hazardous Waste Committee & RSVP

President Wick explained that Resolution 2003-08 is a contract for the pick-up of household hazardous waste by RSVP, in the amount of \$500. Dave Johnson made the motion, and Terry Squibb seconded, that Resolution 2003-08 be adopted. President Wick called for the vote, the motion passed unanimously

KDK-1 Task Order No. 2

President Wick explained Task Order No. 2 was exercised as outlined in the master contract with KDK-1, payment for services is \$4,590.00 and is from the Household Hazardous Waste Committee budget.
