- 2) Aquifer Atlas reprinting 3rd draft comments being incorporated, visit to printers on 12/15/04, printing expected to follow soon thereafter
- 3) Friends of the Aquifer F.Y.I., listing of Idaho water rights issued, 2002-2004
- 4) Dept of Ecology Underground Injection Control rule making per Bill Rickard: Ecology UIC Rule Revision Activity.url http://www.ecy.wa.gov/programs/wq/grndwtr/uic/rule_rev.html, contains adobe acrobat file from power point, same as presented 11/16/04; Eastern WA stormwater manual standards allows for local rules due to local stormwater conditions; local jurisdictions in Spokane County meeting to flesh out regional stormwater manual; City of Spokane Valley proposing making stormwater swales 40% smaller, based on swale to handle but not treat. Proposed reduced design does comply with stormwater manual parameters. City of Spokane and Spokane County not opposed to smaller swale sizes, but concerned about water quality issues; UIC formal rule-making starting Jan '05, along with public comment period; Final rule expected in June 2005. - 5) BNSF Refueling Depot Leak 12/11/04, as reported on KPBX: leaking pipe carrying various materials detected upon routine maintenance; trench 32' deep dug and 200 cu yd material removed; no indication it has reached aquifer level

1) CALL TO ORDER

The Board of Directors of the Spokane Aquifer Joint Board (SAJB) met in Regular Session at Vera Water and Power, 601 N. Evergreen, Spokane, Washington on November 18, 2004. President Wick welcomed those in attendance and called the meeting to order at 1:30 PM.

Board of Directors Roll Call and Introductions

President Ty Wick, Vice-President Bob Ashcraft, Treasurer Steve Skipworth and Secretary Kathleen Small were in attendance. A total of 17 attended the meeting, 12 SAJB member representatives, Program Leader Julia McHugh and 4 Guests.

Consideration of Regular Meeting Minutes

President Wick called for any additions, corrections or comments on the Minutes of October 28, 2004. None were received, President Wick declared the Minutes of October 28, 2004 approved as presented.

2) FINANCE COMMITTEE REPORT

SAJB Administration Funds

Treasurer Steve Skipworth reported as follows: The SAJB Checking Account balance is \$2,516.92 and the Spokane County Investment Pool (Wellhead Protection) balance is \$1,105.99. Treasurer Skipworth stated 2004 yearly dues statements are being distributed, the amount is \$150 per member.

SAJB Wellhead Implementation Plan (WIP) Funds

Mary McIntyre, City of Spokane Accountant, reported as follows: The WIP checking balance is \$ 19,620.92, the Spokane County Investment Pool (Implementation) is \$ 44,830.16 and Implementation Savings is \$73.08.

Presented/Approved Administration and WIP Bills

President Wick presented the attached November 2004 Bill Payment Summary- Total \$ 6,919.15. Those present reviewed the summary. Dave Johnson made the motion, and Terry Squibb seconded, that the bills be paid in accordance with the presented summary. The summary detailed Wellhead Implementation Bills of \$ 6,919.15 including the Program Leader Fee, plus mileage and reimbursement, total \$ 3,723.97 for the period 10/27/04 through 11/16/04. President Wick called for the vote, the motion passed unanimously.

3) OLD BUSINESS

Aguifer quantity study by Washington-Idaho-US Geological Survey (Study)

President Wick reported the study group is trying to set up a public meeting for January. He noted Program Leader McHugh attended the recent meeting, see her report under Item 1) Program Leader Report.

- 1) ID/WA Aquifer study –Policy Advisory meeting November 9 at 3 p.m., Post Falls LibraryAgenda: 1) update on the study, the work plan, the funding, etc. 2) public education/information; and 3) to discuss ideas about the larger public meeting for January 27 at Templins, at 6:30 p.m. Agenda: update on what's been done already toward a bi-state aquifer study, what we've learned, what hydrogeologists and computer modelers are planning to do in the coming year, how the study's funding looks, etc.
- 2) Aquifer Atlas reprinting 3rd draft taking a bit longer, printing expected in December
- 3) The Spokane County Aquifer Protection Area Fees ballot item appears to have passed by a narrow margin. Ballots are still being counted, but it appears to have passed 51% to 49% (34,995 yeah 34,063 nay). There were 92,113 voters eligible to vote on the issue and as of 11/16/04 count 69,058 did vote. The Assistant Elections Manager said it was not a renewal of the item per se, but was redefined by county public works. It is 'good' for another 20 years.
- 4) REQUEST purchase of a long distance calling card for \$20 from Costco. President Wick approved this item for inclusion in the Program Leader's expense reimbursement.
