SPOKANE AQUIFER JOINT BOARD MEETING MINUTES

February 28, 2006

1) CALL TO ORDER

The Board of Directors of the Spokane Aquifer Joint Board (SAJB) met in Regular Session at Pasadena Park Irrigation District No. 17, 9227 E. Upriver Drive, Spokane, Washington on February 28, 2006. President Wick welcomed those in attendance and called the meeting to order at 1:30 PM.

Board of Directors Roll Call and Introductions

President Ty Wick, Vice President Bob Ashcraft, Treasurer Steve Skipworth and Secretary Kathleen Small were in attendance. A total of 16 attended the meeting, 8 SAJB Voting Representatives representing 10 SAJB Entities, 2 Non-Voting SAJB Representatives, Program Leader Julia McHugh and 5 Guests.

Consideration of Regular Meeting Minutes

President Wick called for any additions, corrections or comments on the Minutes of January 26, 2006. The Minutes of January 26, 2006 were approved as presented.

2) FINANCE COMMITTEE REPORT

SAJB Administration Funds

Treasurer Steve Skipworth reported as follows: The SAJB Checking Account balance is \$4,510.27 and the Spokane County Investment Pool (Wellhead Protection) balance is \$1,198.79. Treasurer Skipworth stated no bills payable for February 2006 and SAJB Administration dues have been received from 11 of 20 members.

SAJB Wellhead Implementation Plan (WIP) Funds

Mary McIntyre, Spokane Water Department Accountant, reported as follows: The WIP checking balance is \$ 22,606.80, the Spokane County Investment Pool (Implementation) is \$ 47,430.15 and Implementation Savings is \$73.45.
