SPOKANE AQUIFER JOINT BOARD MEETING MINUTES

1) CALL TO ORDER

The Board of Directors of the Spokane Aquifer Joint Board (SAJB) met in Regular Session at Pasadena Park Irrigation District No. 17, 9227 E. Upriver Drive, Spokane, Washington on April 27. 2006. President Wick welcomed those in attendance and called the meeting to order at 1:30 PM.

Board of Directors Roll Call and Introductions

President Ty Wick, Vice President Bob Ashcraft, Treasurer Mary McIntyre and Secretary Kathleen Small were in attendance. A total of 15 attended the meeting, 10 SAJB Voting Representatives representing 11 SAJB Members, 1 Non-Voting SAJB Representative, Program Leader Julia McHugh and 4 Guests.

Consideration of Regular Meeting Minutes

President Wick called for any additions, corrections or comments on the Minutes of March 23, 2006. The Minutes of March 23, 2006 were approved as presented.

2) FINANCE COMMITTEE REPORT

Treasurer Mary McIntyre reported as follows: SAJB Administration Funds

The SAJB Checking Account balance is \$5,753.11 and the Spokane County Investment Pool (Wellhead Protection) balance is \$1,206.34.

SAJB Wellhead Implementation Plan (WIP) Funds

The WIP checking balance is \$ 13,132.42, the Spokane County Investment Pool (Implementation) is \$ 47,851.66 and Implementation Savings is \$ 73.50.

Presented/Approved Administration and WIP Bills

President Wick presented the attached Bill Payment Summary for April-2006 - Total \$ 61,426.24. Treasurer McIntyre noted that holding payment until next month for the KSPS invoice of \$15,000 would allow collection of additional dues to bring up the balance of the checking account. Those present reviewed the summary, discussion followed. Walt McKee made the motion, and Dan Wren seconded, that the bills be paid accordance with the presented April 2006 Summary, less the KSPS Invoice of \$15,000. The Summary detailed Wellhead Implementation Bills of \$ 61,426.24, minus (\$ 15,000) = \$46,426.24 including the Program Leader Fee, plus mileage and reimbursement, total \$ 5,840.62 for the period March 20 through April 21. President Wick called for the vote, the motion passed unanimously.

3) OLD BUSINESS

Aquifer quantity study by Washington-Idaho-US Geological Survey (Study)

President Wick reported the Study is out taking aquifer level readings this week. Also see Program Leader Report 2).

Aquifer Protection Council

Program Leader McHugh said there has been a meeting with the Idaho folks – they got the funding option through the legislature and will now ask the people to vote to approve the tax.

2006 Program Leader Contract

Program Leader McHugh excused herself from the meeting. Those present discussed the Program Leader current contract and her request to reduce the hours by 25% as the Program has matured away from the development stage into full implementation. Tim Schudel made the motion, and Dan Wren seconded, that the Program Leader contract run from May 1, 2006 through April 30, 2007, estimated maximum hours of 1,335 hours annually and compensation to be a lump sum of \$51,240.00 per year paid in 12 monthly installments of \$4,270.00. President Wick called for the vote, the motion passed unanimously. President Wick will prepare the Program Leader contract for signature. Program Leader McHugh rejoined the meeting.

Conservation Committee

President Wick reported the Conservation Committee met and reviewed indoor and outdoor conservation options, with the intent to get a funding package together to submit to the DOE Watershed Planning Group. This is a placeholder action for funding that is to become available in 2007.

Walt McKee nominated Ty Wick as President, Bob Ashcraft as Vice-President and Kathy Small as Secretary. There were no other nominations. President Wick stated officer elections would take place at the May meeting. President Wick announced that Mary McIntyre has accepted the appointment to the position of Treasurer for SAJB.
