

SPOKANE AQUIFER JOINT BOARD MEETING MINUTES

March 26, 2015

1) CALL TO ORDER

The Board of Directors of the Spokane Aquifer Joint Board (SAJB) met in Regular Session at Spokane County Water District No. 3, 1225 N. Yardley Street, Spokane, Washington 99212. President Ty Wick was in attendance. A total of 17 attended the meeting; including 12 SAJB voting representatives, 0 non-voting members, Program Manager Hanson and 4 guests. The sign-in sheet of SAJB members and guests is available upon request.

Consideration of Regular Meeting Minutes

President Wick called for any additions, corrections or deletions to the Minutes of February 19, 2015. Hearing none, the Minutes for February were approved as submitted.

2) FINANCE COMMITTEE REPORT

President Ty Wick reported for the Treasurer.

SAJB Administration Funds

The SAJB checking balance for March 2015 is \$3,642.01.

SAJB Wellhead Implementation Plan (WIP) Funds

The WIP checking balance is \$11,235.79. The Spokane County Investment Pool (Implementation) balance is \$58,349.29.

Administration and WIP Bill Summary for March 2015

President Wick presented the Bill Payment Summary for the month of March 2015.

The March 2015 Bill Payment Summary totaled \$3,957.55. The March summary detailed SAJB Administration bills of \$0.00 and Wellhead Implementation Bills of \$1,500.00. The Program Manager Consulting Services including mileage and reimbursements for the month of March amounted to \$2,907.55

Those present reviewed the March Bill Payment Summary. Scott Inch moved to approve the Bill Payment Summary as presented. BiJay Adams seconded the motion. President Wick called for the vote, the motion carried unanimously.

3) OLD BUSINESS

Wellhead Regulatory Process and Wellhead Protection – Doug Greenlund reported that Lloyd Brewer met with the City of Spokane's Mayor and his staff who have additional questions regarding the wellhead protection proposal. The process continues to move forward.

Idaho Washington Aquifer Collaborative (IWAC) – Met on 3/10/15. Mark Solomon, Ph.D., Water Research Scientist, Idaho Water Resources Research Institute (IWRRI), University of Idaho, presented the Rathdrum Prairie Aquifer Future Municipal Water Demand study. Mark described the process and methodology by which Idaho purveyors file water right applications based on **Reasonably Anticipated Future Needs** (RAFN) as provided for by Idaho law. 2015 Aquifer Atlas Update – Jeremy Jenkins and Reanette Boese reported that the 2015 Aquifer Atlas is under external review by IDEQ's technical editors. When the IDEQ review is completed the DRAFT 2015 Aquifer Atlas will be sent to SAJB members for comment. Jim Ekins at University of Idaho is working with Kristen Zimmer, KSPS/City of Spokane, on a companion guide for Educators and Parents.

GSI Water Solutions, Inc. Historical Analysis Scope - "Technical Approach, Scope of Work, and Cost Estimate for Conducting a Phased Analysis of the Causes of Historical Changes to Seasonal Low Flows in the Spokane River. Jeremy Jenkins met with Ben Serr at the Department of Health – Division of Drinking Water (DOH) to determine if this study would qualify for DOH aquifer protection funds. Ben passed the question on to Kitty Weisman. The study, as written, does not meet the aquifer protection grant criteria. Ty and Jeremy will work with John Porcello and attempt to adjust the scope of work to fit the source water funding guidelines.

2015 SAJB Assessment - Change in DOH Reporting - BiJay Adams informed SAJB members that DOH Water Facilities Inventory (WFI) updates have been changed to a 3 year cycle. The information currently used to determine SAJB assessments, (WFI Form boxes: 25A - Full Time Single Family Residences and 26A - Apartment Buildings, condos, duplexes, barracks, dorms) may not reflect annual connection numbers. SAJB members present discussed the situation and agreed that they would still be able to provide the correct assessment numbers annually.

4) NEW BUSINESS

Resolution 2015-05 SAJB-Spokane County Interlocal Agreement PCSI President Wick opened discussion on Resolution 2015-05, the Interlocal agreement between SAJB and Spokane County for annual Potential Contaminant Source Inventories (PCSI). Resolution 2015-05 was distributed for member review on March 16, 2015. Scott Inch moved to approve Resolution 2015-05 and Terry Squibb seconded the motion. President Wick called for the vote and the motion passed unanimously.

Reanette Boese reported that the 2015 PCSI business data has been compiled. Changes for this year include parcel numbers to verify the capture zones in GIS. Updated information has been included in the directions. 2015 PCSI lists will be distributed for review and return.

Billboard Design – Spokane Waste Directory – Draft billboard designs were presented for member review. Numerous changes were requested. Members agreed to look at new drafts via e-mail and select a final design before the April 23rd meeting.

City of Spokane Valley Comprehensive Plan – President Wick reported that the City of Spokane Valley is updating their Comprehensive Plan. Water systems are invited to review and provide comments on water services, future water needs and areas within the municipal codes that may need to be strengthened. President Wick called for volunteers. Todd Henry and Bryan St. Clair volunteered to participate in reviewing the comprehensive plan.

- o **KSPS Public TV** 30 spots /month are currently running.


