Old Business

Aquifer Atlas: Jeremy Jenkins reported that the 2015 SVRP Aquifer Atlas was in the final review process and scheduled to be printed in June. Jim Ekins provided a sample of Aquifer Atlas educational materials. Kristen Zimmer, City of Spokane, is collaborating with Jim to compile resources and new lessons are being developed by UI pre-service teachers. The aquifer education materials will be available electronically, by fall 2015, on a yet to be determined website.

Aquifer Protection Discussion: The implications of an increasing number and frequency of oil trains travelling over the SVRP Aquifer and near the Spokane River were discussed. Those present decided to invite a guest panel to the May 12th IWAC meeting to further discuss emergency preparedness and potential spill response. Suggestions were made for guest panelists from Idaho and Washington emergency responders, railroad and elected officials. Bob Haynes and Tonilee Hanson will follow-up and invite guests for May.
