# **RESOLUTION NO. 2016-02**

A RESOLUTION OF THE BOARD OF THE SPOKANE AQUIFER JOINT BOARD, SPOKANE COUNTY, WASHINGTON, AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH KSPS PUBLIC TELEVISION TO PROVIDE SERVICES ASSOCIATED WITH THE EDUCATION AND AWARENESS COMMITTEE; AND OTHER MATTERS PROPERLY RELATING THERETO

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE SPOKANE AQUIFER JOINT BOARD, OF SPOKANE COUNTY, WASHINGTON, as follows:

WHEREAS, the Spokane Aquifer Joint Board ("SAJB") has been created for the Spokane County Region by action of the respective Boards of Directors and/or authorized representatives of the municipal corporations involved pursuant to RCW 39.34, known as the Washington Interlocal Cooperation Act; and

WHEREAS, the members of the SAJB executed an agreement forming the Joint Board ("the Agreement"), which provides rules for the process the Board follows in conducting its business, including the entering into and execution of agreements; and

WHEREAS, the Board of SAJB revised Resolution No. 95-01 on October 25, 2001, which provides that a simple majority of the eligible voting Board Members must vote on major decisions, including the execution of Personal Services Agreements; and

**WHEREAS**, the Board wishes to utilize the services of KSPS Public Television to assist the Education and Awareness Committee in raising awareness about conserving water and protecting the aquifer by entering into this agreement;

NOW, THEREFORE, BE IT FURTHER RESOLVED by the Board of the Spokane Aquifer Joint Board as follows:

<u>Section 1:</u> The Board hereby approves the execution of this Agreement with KSPS Public Television, generally in the form of Exhibit "A", attached hereto and incorporated herein by this reference, and authorizes and directs the appropriate officials of the Board to execute said agreement.

<u>Section 2:</u> This Resolution shall become effective upon its adoption and execution by the appropriate officers of SAJB.

KSPS is honored to be in partnership with the **Spokane Aquifer Joint Board**. Our continuing collaboration affords a wide array of opportunities to develop additional educational and promotional programs. Our partnership encourages students, teachers and viewers to be more informed and enlightened, whether it is through our educational outreach curriculum or exceptional children and adult focused programs: The following bullets discuss what KSPS proposes to SAJB in 2016.

#### **Overview of Benefits:**

- KSPS will develop and conduct up to 50 "Aquifer in a Cup" workshops featuring Aquifer-related materials to school districts, both public and private, located throughout the Washington State portions of the Spokane Valley Rathdrum Prairie Aquifer boundaries during the school year from February 2016 through January 2017. \$500 per workshop x 50
- KSPS will distribute **SAJB materials** (listed below) **and a set of five books** to all workshop attendees and create co-branded learning materials.
  - KSPS will purchase the sets of books and will include a co-branded bookplate in each book.
  - KSPS will create and distribute packets of printed materials called "Groundwater: The Wonder Down Under" which include puzzles, fun facts and aquifer- related worksheets, all approved by SAJB.
  - SAJB will provide other items including folders, Aqua Duck comic books, bookmarks, atlases and tote bags for teachers.
- KSPS will hold a **multi-media "Got Waste? Put It In the Right Place" student contest** running from February 10 through March 31, 2016 promoting the "Got Waste?" campaign. Awards will be distributed in early April 2016. The contest will be posted on our website and flyers will be distributed throughout area schools: East Valley, West Valley, Central Valley, District 81 and all parochial and private schools. The winning media presentation(s) will be displayed on both KSPS and SAJB's website. Students will be asked to participate with one winner from each grade, K-6. Each winner will receive a prize. Each winner's classroom will receive a pack of educational and fun waterrelated activities.
- KSPS will have Aqua Duck participate at **Kids Day** in August 2016. Kids will receive Aqua Duck printed materials. Kids Day takes place at Riverfront Park and has an attendance of thousands. Event will be promoted on air via the KSPS Kids Calendar, and on KSPS.org.
- Aqua Duck will participate in *KSPS FitKids Day*, also in August. This is a day of fun activities for young children. About 800 Spokane children/families are expected to attend.
- KSPS will help secure **Aqua Duck appearances** at other community events as appropriate.
- KSPS will continue to update and maintain an educational/Aquifer web portal on KSPS.org focusing on educators and families with pertinent educational information and activities for kids. It will showcase winners of the *Got Waste? Student Contest* and will include links to <u>www.spokaneaquifer.org</u>, <u>www.SpokaneWasteDirectory.org</u> or

other websites as requested by SAJB.

- KSPS will provide ads on the <u>ksps.org</u> home page for 2 weeks per quarter, including links to appropriate web sites. KSPS will create these ads or may use ads provided by SAJB. (8 weeks of home page ads)
- KSPS will place a minimum of 2 social media posts per channel/per month (minimum 24 posts per channel year) to KSPS' Facebook, Twitter and Instagram accounts to promote specific SAJB activities and campaigns. (minimum 6 posts/month)
