

SPOKANE AQUIFER JOINT BOARD MEETING MINUTES

January 26, 2016

1) CALL TO ORDER

The Board of Directors of the Spokane Aquifer Joint Board (SAJB) met in Regular Session at Spokane County Water District No. 3, 1225 N. Yardley Street, Spokane, Washington 99212. A total of 15 attended the meeting; including 9 SAJB voting representatives, 1 SAJB alternate voting representative, 2 non-voting members, Program Manager Hanson and 2 guests. The sign-in sheet of SAJB members and guests is available upon request. A quorum of voting members was not in attendance.

2) FINANCE COMMITTEE REPORT

President Wick presented the Treasurer's financial reports for information only.

SAJB Administration Funds

The SAJB checking balance for December 2016 Year End is \$431.43. The January 26, 2017 balance is \$431.43.
