

# SPOKANE AQUIFER JOINT BOARD MEETING MINUTES

December 13, 2018

# 1) CALL TO ORDER

The Board of Directors of the Spokane Aquifer Joint Board (SAJB) met in Regular Session at Modern Electric Water Company. A total of 19 attended the meeting including 12 SAJB voting representatives, 1 SAJB alternate voting representative, 2 non-voting members, and 4 guests. Program Manager Hanson was absent. The sign-in sheet of SAJB members and guests is available upon request. The meeting was called to order at 1:34 pm.

#### **Consideration of Regular Meeting Minutes**

President Jeremy Jenkins called for any additions, corrections or deletions to the Minutes of November 29, 2018. Hearing none, Bruce Davidson moved to approve the minutes as submitted and Lance Peterson seconded the motion. President Jenkins called for a vote and the motion carried unanimously.

# 2) FINANCE COMMITTEE REPORT

Treasurer, Bryan St. Clair presented the financial reports for December 2018.

#### **SAJB Administration Funds**

The SAJB checking balance for December 13, 2018 is \$1,137.23

#### SAJB Wellhead Implementation Plan (WIP) Funds

The Spokane County Investment Pool (Implementation) balance is \$45,137.57

#### Administration and WIP Bill Payment Summary

The **December Bill Payment Summary** totaled \$13,951.01 paid with checks numbered 2400-2402. The December summary detailed SAJB Administration bills of \$0.00 and Wellhead Implementation Bills of \$12,450.00. The Program Manager Consulting Services including mileage and reimbursements for the month of December amounted to \$1501.01.

Those present reviewed the summary. Scott Inch moved to approve the December Bill Payment Summary as presented. BiJay Adams seconded the motion. President Jenkins called for the vote, the motion carried unanimously.

#### 3) OLD BUSINESS

America's Water Infrastructure Act of 2018 - Doug Greenlund – Section 2008 Improved CCR, beginning in 2020, large water systems are required to provide biannual CCRs. All systems will need to report information on corrosion control, exceedances and violations. Section 2013 Community Water System Risk and Resilience, has expanded criteria and requires a vulnerability assessment every 5 years. Detailed guidance on implementation is still needed. Read the October 2018 Draft from USEPA.

Idaho Washington Aquifer Collaborative (IWAC) – Andy Dunau, Spokane River Forum (SRF), presented a preview of SRF Conference sessions. The 2019 Conference theme is "Resiliency." Craig Anderson, Wayne Carlson and Brittany Port of AHBL, reviewed the Irrigation and Landscape Design Standards guidance document development outline. AHBL representatives will return on February 12, 2019, 1:30 pm to review work completed on the guidance documents. The goal is to complete the model standards for presentation at the SRF Conference on April 16, 2019. IWAC meetings are held the second Tuesday of the month at Liberty Lake Sewer and Water District.

KSPS 2018 Final Report – Dawn Bayman and Carl Heidle reviewed the 2018 KSPS education and awareness media services. Below are the summary highlights.

**2019 Budget Approval -** The 2019 budget was reviewed, and media ideas were discussed for new 2019 media marketing possibilities. Paul Allen moved to approve the 2019 budget

and Bijay Adams seconded the motion. President Jenkins called for a vote and the motion passed unanimously.

A question was raised about a cost of living adjustment (COLA) for the Program Manager (PM). Discussion followed. Paul Allen moved to rescind the motion to approve the 2019 budget and BiJay seconded the motion. BiJay Adams made a motion to amend the 2019 budget to increase the PM line item from \$43,000 to \$45,150 which is a 5% COLA. Bruce Davidson seconded the motion. President Jenkins called for the vote to approve the Program Manager's cost of living adjustment and the motion passed unanimously. In January, the 2019 Program Manager resolution will be updated to reflect the COLA.

Bruce Davidson moved to reapprove the 2019 budget with the approved Program Manager's cost of living adjustment. BiJay Adams seconded the motion. President Jenkins called for a vote and the motion passed unanimously.

**Business Assistance**: EnviroCertified Recognition Program – In 2018, the EnviroStars Business recognition Program was successfully relaunched as the EnviroCertified Program.
