

SPOKANE AQUIFER JOINT BOARD MEETING MINUTES

March 24, 2022

SAJB Officers:

1. CALL TO ORDER

The Board of Directors of the Spokane Aquifer Joint Board (SAJB) met in Regular Session via Zoom. A total of twenty (20) attended the meeting including: ten (10) SAJB voting representatives, one (1) voting alternate, one (1) non-voting member, Program Manager Hanson, and seven (7) guests. The sign-in sheet of SAJB members and guests is available upon request. The meeting was called to order at 1:33 pm.

Consideration of Regular Meeting Minutes

President Jeremy Jenkins called for any additions, corrections, or deletions to the Minutes of February 24, 2022. Justin VanDyke moved to approve the February minutes and Terry Squibb seconded the motion. President Jenkins called for a vote and the motion carried unanimously.

2. FINANCAL REPORT

Resolution 2022-05 Gregory Geologic – Increase Not to Exceed Amount - Guy Gregory drafted responses to the November 2021 and March 2022 City of Airway Heights New Water Rights SEPA checklists. Guy submitted numerous public records requests to the Washington State Department of Ecology and the City of Airway Heights and reviewed the materials received. The funding limit for Resolution 2022-05 has been reached. A Report of Examination will be expected in 2022 and SAJB needs to be prepared to respond especially if it occurs during the SAJB construction recess. Vice President Shane Sheppard moved to raise the funding limit to \$5,000 and allow SAJB officers to adjust the limit if needed during the recess. BiJay Adams seconded the motion. President Jenkins called for the vote and the motion passed with 9 ayes and 0 nays.

Resolution 2022-03 Blue Sky Marketing – Blue Sky Marketing owner, Ada Hargrove, passed away in January. Ada contracted with Phase 3 Digital for the SAJB media campaigns. Phase 3 Digital Senior Account Executive, Roger Nelson, has agreed to honor the original contract terms. SAJB members discussed the appropriate actions to make the transition to Phase 3 Digital. It was agreed that a new Resolution for Phase 3 Digital will need to be presented for a vote at the April SAJB meeting. A W-9 will also be needed for bill payment.

Administration and WIP Bill Payment Summary

Treasurer Greenlund presented the March Bill Payment Summary which totaled \$16,684.58 and was paid with checks numbered 2578-2581. The March summary detailed SAJB Administration bills of \$0.00 and Wellhead Implementation Bills of \$12,754.5. The Program Manager Consulting Services including mileage and reimbursements for the month of March amounted to \$3,930.08.

Those present reviewed the bill payment summaries. Terry Squibb moved to approve the March Bill Payment Summary as submitted. Rick Neal seconded the motion. President Jenkins called for the vote and the motion carried unanimously. Treasurer Greenlund expressed his appreciation for all who paid their Dues and Assessments promptly. Only 2 member payments are still outstanding, and they have been contacted.

SAJB Wellhead Implementation Plan (WIP) Funds

The SAJB Administrative checking balance for March 2022 is \$7,294.85. The SAJB WIP checking balance for March 2022 is \$126,721.55. The Spokane County Investment Pool (WIP) balance is \$47,577.83.

3. OLD BUSINESS

Ty Wick Award Nominations – The Award committee met and reviewed the nominations. The winner or winners will be announced at the Spokane River Forum's H_2O Breakfast. The date is May 26, 2022.

DOH Source Water Protection Grant has been awarded, President Jenkins and Deborah Johnson are working to re-orient some of the deliverables. Additional forms are required before funding can be released. The grant process is close to completion and the work with GSI will soon move forward to develop the risk assessment and determine possible actions to protect the aquifer.

City of Airway Heights (CAWH) Withdrawal and Notice of New Water Rights SEPA was received on March 3, 2022, with a deadline for comments of 3/17/22 at 4:30 pm. Below is an excerpt from SAJB comments prepared by Guy Gregory, informed by Public Records Requests of the CAWH and Ecology. CAWH did not include the Engineering Evaluation/Cost Analysis (EE/CA) in the SEPA.

Engineering Evaluation/Cost Analysis (EE/CA), Fairchild Air Force Base and City of Airway Heights, Washington, prepared by Brice Environmental Services and AECOM Joint Venture for Air Force Civil Engineer Center and the U.S. Army Corps of Engineers, Seattle District, dated June 2021.

The above document was specifically, "prepared to evaluate removal action alternatives for mitigating impacts from perfluorooctane sulfonate (PFOS) and perfluorooctanoic acid (PFOA) in drinking water for City of Airway Heights, Washington, in accordance with Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA)." As such it should be referenced as "environmental information you know about that has been prepared, or will be prepared, directly related to this proposal." (Section A.8).

The EE/CA study evaluates 5 alternatives for addressing the contamination including "Alternative 5 – New Water Supply Well with Connection to Airway Heights Water System." This alternative as described in the EE/CA Section 4.6.1 is quite similar, though substantially more detailed, than that described in the Threshold Determination. The EE/CA concludes that the new water supply well alternative is not preferred because of cost and (EE/CA, pg. 4-15), "the technical feasibility of acquiring easements, construction, and water rights is not likely to be straightforward and the availability of resources is uncertain." Alternative 5 was determined (EE/CA, pg. 5-2) to be "the lowest cost alternative, but it has the highest capital cost and the highest potential impact to the environment."

The EE/CA Executive Summary indicates the selected alternative, "will be documented in an Action Memorandum. FAFB (Fairchild Air Force Base) intends to initiate the Removal Action in 2022, provided all required regulatory documents, plans, and permits are approved."

<u>SAJB's response to the 2022 New Water Rights CAWH SEPA</u> can be read in full by clicking on the link. President Jenkins reported that he checks every Wednesday to see if a Record of Examination by the WA Dept of Ecology has been released regarding the CAWH new water rights SEPA.

2022 PCSI – Reanette Boese sent each SAJB purveyor a spreadsheet to review that includes new and existing PCSI candidates.
