

SPOKANE AQUIFER JOINT BOARD MEETING MINUTES

January 19, 2023

1. CALL TO ORDER

The Board of Directors of the Spokane Aquifer Joint Board (SAJB) met in Regular Session via Zoom and in person at SCWD#3. A total of twenty (20) attended the meeting including: eleven (11) SAJB voting representatives, one (1) voting alternate, one (1) non-voting member, Program Manager Hanson, and five (5) guests. Terry Squibb General Manager of Carnhope and Hutchinson signed in but was called away before the meeting began. Terry was counted in the total but not in the quorum. The sign-in sheet of SAJB members and guests is available upon request. The meeting was called to order at 1:36 pm. President Jenkins asked everyone in person and via zoom to introduce themselves.

Consideration of Regular Meeting Minutes

President Jeremy Jenkins called for any additions, corrections, or deletions to the Minutes of December 15, 2022. Doug Greenlund moved to approve the meeting minutes for December. Rick Neal seconded the motion. President Jenkins called for discussion and the vote. The motion was approved unanimously.

2. NEW BUSINESS

Approval of 2023 Resolutions was moved ahead of January Financials in the Agenda to authorize payment of invoices. Resolutions were sent to members for review one week in advance of the meeting. President Jenkins summarized each resolution and asked for discussion prior to each vote.

Resolution 2023-01 SAJB_KSPS PBS

Doug Greenlund moved to approve Resolution 2023-01. Paul Allen seconded the motion, President Jenkins called for discussion and a vote. Resolution 2023-01 passed with 11 ayes and 0 nays.

Resolution 2023-02 SAJB_Spokane River Forum

Justin VanDyke moved to approve Resolution 2023-02. Rick Neal seconded the motion, President Jenkins called for discussion and a vote. Resolution 2023-02 passed with 11 ayes and 0 nays.

Resolution 2023-03 SAJB_Phase 3 Digital

Doug Greenlund moved to approve Resolution 2023-03. Scott Inch seconded the motion, President Jenkins called for discussion and a vote. Resolution 2023-03 passed with 11 ayes and 0 nays.

Resolution 2023-04 SAJB_Boese Water Resources

Scott Inch moved to approve Resolution 2023-04. Rick Neal seconded the motion, President Jenkins called for discussion and a vote. Resolution 2023-04 passed with 11 ayes and 0 nays.

Resolution 2023-05 SAJB_Program Manager

Shane Sheppard moved to approve Resolution 2023-05. Doug Greenlund seconded the motion, President Jenkins called for discussion and a vote. Resolution 2023-05 passed with 11 ayes and 0 nays.

3. FINANCAL REPORT

Administration and WIP Bill Payment Summary

Treasurer Greenlund presented the January Bill Payment Summary for approval.

January 2023 Bill Payments totaled \$5,664.02. The January summary detailed SAJB Administration bills of \$46.05 paid with check numbered 1036. Wellhead Implementation bills were paid with checks numbered 2621 - 2623. Education and Awareness bills of \$2,696.25. Program Manager Consulting Services, mileage and reimbursements amounted to \$2,967.77.

Those present reviewed the bill payment summary. Bruce Davidson moved to approve the January Bill Payment Summary. Scott Inch seconded the motion. President Jenkins called for the vote and the motion passed unanimously.

SAJB Fund Balances

The SAJB Administrative checking balance for January 2023 is \$1,851.41. The SAJB WIP checking balance for January 2023 is \$44,376.50. The Spokane County Investment Pool balance is \$48,058.46.

2023 Assessments and Dues – Treasurer Greenlund thanked everyone for providing their connection numbers. Assessment and dues invoices are ready and will be given to the members present and mailed to members who are not in person today. Treasurer Greenlund requested that dues and assessments be paid by March 1, 2023 and that separate checks be drawn for the Administrative Dues and the Wellhead Implementation Program Assessment. All 1099s will be sent this week.

3. OLD BUSINESS

Aggregate Quarries – GSI Water Solutions Risk Assessment. Dan Kegley reported that GSI Water Solutions is still waiting for many of the Public Records Requests which makes the March DOH Grant Deadline challenging. GSI will submit a progress report to DOH and request a 6-week extension.

2023 Ty Wick Award – <u>Award nominations</u> from Idaho and Washington are open online until April 3, 2023. The award will be presented at the Spokane River Forum Conference, April 26 – 27, 2023 at the Spokane Convention Center. KSPS is airing the Ty Wick award video and Phase 3 Digital will advertise the award from February 1^{st} through March 31^{st} .

SRC4 Seminar January 26, 2023, will be held in-person at Whitworth University's HUB from 8:00 am to 3:30 pm. The cost is \$100. Five (5) CEUs have been approved. PFAS – Spokane Regional Health District – Mike LaScuola was not able to be at the SAJB meeting so he sent information about a **Statewide PFAS Forum.** Planning is in process.

Expected date: Early to mid-June 2023 **Purpose:** To stimulate learning and problem-solving around PFAS in surface and groundwater. **Intended Audience:** WWTPs, PWS, private wells, cities, counties, tribes, agency program staff, policy folks, community representatives from impacted communities.

Size/Format of Conference: Hybrid with virtual presentations and mix of online participants and in-person groups at 3-5 locations around the state. Facilitated discussions in online breakout groups or in-person venues. Facilitators report back to whole group. **Possible Topics/ Panels:** See document emailed from Mike LaScuola

Discussion included PFAS impacts, testing, and sources. Doug Greenlund sent a link information on applying for UCMR5 GWRMP, a reduced well sampling plan. 
SAJB April Meeting Date was moved to Thursday, April 20, 2023, to allow participation in the SRF Conference


